We agree that no suit may be brought or claim made for injuries sustained by the child (and further agree to defend and hold harmless Gold for the Gold Gymnastics and any staff, manager, officer, agent, servant or employee, or coach of said organizations, for all claims, lawsuits and expenses made by or on behalf of our child, for any injury he or she may suffer, arising by virtue of such claims or lawsuits).
